SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures

8.2 Exposure controls

Engineering controls: Use local exhaust ventilation, or other engineering controls to maintain airborne levels below exposure limit requirements or guidelines. Examples of acceptable glove barrier materials include: Natural rubber ("latex").
